***Annex 1 to the Invitation –Description of the Subject of the Contract
Competition for tender No. 4/2025***

The subject of the contract is the supply of a **complete satellite terminal** (hereinafter: “Device”) **together with equipment, training services and an assured warranty period of at least 36 months, necessary for the implementation of the “SAT2Rescue”** project Secured SATCOM-based solution enhancing emergency services and search & rescue missions , co-financed by the European Union (“EU”) represented by the European Union Agency for the Space Programme - the body delegated by the European Commission (Project 101180110 - SAT2Rescue - HORIZON-EUSPA-2023-SPACE, 4.10.2024).

The SAT2Rescue project, within the framework of which the Employer will implement the Subject of the Contract, is intended to introduce a state-of-the-art solution for emergency services and for telemedicine applications in the framework of humanitarian aid, using the infrastructure and services of GOVSATCOM - a European Union initiative providing secure satellite communications for governments and organisations.

The offered Device must be compatible with the satellite system that the Ordering Party has at its disposal, due to the fact that as part of the implemented research and development project, which assumes the demonstration of satellite communications for crisis and rescue situations, EXATEL is responsible for the implementation of satellite communications. In addition, the Device offered by the Contractor must have mobile properties, which means that it should work in motion and when stationary and at the same time work with iDirect modems, i.e. with the satellite system used in EXATEL.

The equipment necessary for the implementation of the aforementioned project is strictly specialised equipment, which must meet all the technical requirements specified by the Employer in the Description of the Subject of the Contract.

Scope of the Subject of the Contract within the framework of the conducted purchasing procedure:

1. Supply of one a **complete satellite terminal with equipment** (hereinafter: “Device”) which includes:

LP. 1 Device **satellite terminal** (an example of a device that meets The Employer’s requirements - KYMETA GOSHAWK U8, 20 W BUC, OW, LTE ADV PRO (GLOBAL), GRAY, GO U88-00011-0) – 1 szt.

LP. 2 Cable and power supply sets **compatible with the satellite terminal Device offered by the Contractor, allowing its connection to a vehicle or to a building power supply:**

- a) Accessories - Cable set – cables with a protection degree of at least IP66, with the possibility of connecting the Device to an external modem (an example of a device that meets The Employer's requirements - RX, TX, DATA FOR ODU, 25' (7.5M) , KYMETA U8ACC-00013-0) – 2 sets
- b) Accessories – power kit – a set necessary to enable the Device to be powered from a wall socket, accessories should have a protection class of at least IP66, accessories should also be equipped with IEC C13 - UE (CEE 7/7) (an example of a device that meets The Employer's requirements - AC-DC, 20' (6 M) AC, 8' DC, NEMA i CE , KYMETA U8ACC-00044-0) – 2 kpl.
- c) Accessories – Cable set (an example of a device that meets The Employer's requirements - KYMETA KIT, GOSHAWK, U8ACC-00110-0)- 2 sets.

LP. 3) Accessories – mountings for the Device - **compatible with the satellite terminal Device offered by the Contractor:**

- a) Accessories – a mounting bracket that should allow the Device to be attached to a pole for permanent installation. The bracket should allow for a tilt of at least 45° (an example of a device that meets The Employer's requirements - KYMETA U8ACC-00054-0) – 1 pcs.
- b) Accessories – mounting bracket for vehicle roof racks (an example of a device that meets The Employer's requirements - KYMETA VEHICLE RACK MOUNT /U8ACC-00055-0)- 1 pcs.

ATTENTION:

The Employer due to the specific nature of the Subject of the Contract and the impossibility of using sufficiently precise terms in the specification that would allow the Contractor to understand the needs of the Employer's, the Employer has indicated above example models of specific Devices and accessories.

- 2. Provision of a 36-month warranty with support and a warranty service provided by the manufacturer (or by entities authorised by the manufacturer) in accordance with the requirements described in point 6 below for the Equipment.
- 3. Remote training in the configuration and use of the Equipment, provided by the equipment manufacturer, for a group of at least 5 users. **The Contractor should provide the Employer with access to online training 24/7/365 with the possibility of repeating it.**

The end user of the Equipment will be the Employer.

Furthermore, the Employer requires that:

- 1. The Equipment is brand new (in original packaging containing all factory-packed materials).
- 2. The Equipment has been delivered with all the necessary materials required for installation and commissioning.
- 3. The equipment came from a legitimate distribution channel.
- 4. The equipment was covered by the manufacturer's warranty and warranty service provided by the manufacturer (or by entities authorised by the manufacturer), which will be confirmed by the original warranty cards.

5. The period of the warranty and technical support should be guaranteed for at least the period indicated in the Description of the Subject of the Contract and the Contractor's tender.
6. The warranty service for the supplied Equipment, under the warranty referred to hereinabove, should be provided by the manufacturer (or by entities authorised by the manufacturer) on the following terms and conditions:
 - 6.1. The service shall be available **for 5 days a week (Monday – Friday), between the following hours [8:00 a.m. and 4:00 p.m.**, and shall be provided via phone or e-mail or via the IT tool/website of the manufacturer of the Equipment indicated by the Contractor.
7. The Contractor shall, not later than on the date of delivery of the Device, provide the Employer with complete user documentation for the Device in English prepared by the Manufacturer of the Device.
8. The Contractor shall, not later than on the date of delivery of the Device, provide the Employer with access to the notification system of the Manufacturer of the Device for technical support needs, which shall be active for 36 months from the date of delivery of the Device to the Employer.
9. The Manufacturer of the Device shall provide the remote training in the configuration and operation of the Device for a minimum 5 users designated by the Employer.
10. The Contractor shall, for the duration of the warranty and support for the Device, provide free access to software updates for the Device.
11. Furthermore, for the offered Device, the Contractor undertakes to provide the Employer, free of charge, with all required licence and activation keys, so that the Device has all functionalities made available by the Manufacturer of the Device active.
12. The Employer requires the provision of a non-expiring licence for the supplied System for its use
13. By a non-expiring licence, the Employer shall mean a licence granted for an indefinite period of time, in respect of which the licensor unconditionally waives the right of its termination and cancellation.
14. Within the scope of the warranty granted for the offered Device, the Employer shall have the right to download patches, updates and new software versions in a manner that does not infringe upon the rights of the developers and the owner of the copyright and does not restrict the rights of the Employer to use this Device.
15. The Employer may exercise warranty rights independently of the rights under the quality guarantee.

ATTENTION!

- In all places in this Invitation where an exemplary trademark, patent or origin is used, it is justified by the specificity of the subject of the contract and the Employer cannot describe the subject of the contract using sufficiently precise terms.
- If the Employer has indicated brands or trade names, this determines the class of the product that is the subject of the order and serves to establish a standard, and does not indicate a specific product or manufacturer.

- The Employer will recognise as equivalent those solutions which are based on equivalent arrangements as to the subject of the contract and will meet the minimum requirements which are met by the product described by using an exemplary trademark, patent or origin.
- A contractor who invokes equivalent solutions described by the Employer is obliged to prove in his offer that the subject of the supply offered by it meets the requirements specified by the Employer.
- The burden of proof for proving the equivalence of the solutions offered with the solutions described by indicating an exemplary trademark, patent or origin, rests with the Contractor submitting an equivalent offer.
